Information to applicants regarding GDPR within the Rimaster Group

In reviewing your application and to administrate the job application process, Rimaster will process the personal data that you supply in your application or through other means of communication with Rimaster. This includes, for instance, name, social security number, contact information, and work and educational history. Rimaster may also collect personal data about you from available open sources, such as national population registers.

By submitting your application, you consent for Rimaster to process your personal data. You have the right to revoke your consent at any time and request the deletion of your application during the application process.

Rimaster will process your personal data for the time necessary to complete the selection process and, in case of employment, for at least the duration of the employment. Your personal data may also be further processed for archiving purposes.

As a general rule, Rimaster will not share your personal data with actors outside of the Rimaster Group, with the exception of potential sub-contractors who maintain relevant IT-systems and in response to requests from competent public authorities.

Under the General Data Protection Regulation, you have a right of access, a right to rectification, erasure and to the restriction of the processing and a right to data portability.

If you are not satisfied with the processing of your personal data by Rimaster, you have a right to lodge a complaint with the supervisory authority in the country in which you reside. Nonetheless, you are always welcome to first contact the Data Protection Officer of Rimaster if you are not satisfied with the processing of your personal data.
